This agreement is not transferable or assignable without prior written consent of Seller. This agreement shall become effective upon acceptance by Seller. Seller reserves the right to modify, curtail, or eliminate credit availability to the Buyer within its sole discretion. Buyer agrees that all sales shall be governed by Seller's standard terms and conditions of sale and posted on Seller's internet site at [www.enterprisedatagroup.com](http://www.enterprisedatagroup.com), unless Seller and Buyer have executed a separate agreement which specifically supersedes and replaces those terms and conditions. No terms or conditions of any purchase order or similar document shall be binding on Seller contrary to Seller's published standard terms and conditions. This agreement and all other agreements with Seller including but not limited to, the standard terms and conditions of sale, are considered to be single integrated agreement. **BOTH PARTIES WAIVE TRIAL BY JURY IN ANY ACTION, PROCEEDING, CLAIM, OR COUNTERCLAIM BROUGHT BY EITHER PARTY IN CONNECTION WITH ANY MATTER ARISING OUT OF OR IN ANY WAY CONNECTED WITH THIS CREDIT APPLICATION AND ANY AGREEMENT HEREUNDER.** Buyer hereby represents and warrants that the information provided in this application and in any and all additional documents, financial statement or other information furnished by Buyer to Seller is accurate and true in all material respects and contains all information necessary so that this application is not materially misleading. Buyer acknowledges that Seller is relying on the accuracy of the information provided by the Buyer. The Buyer consents to and authorizes the release of all banking and credit information.
